

# M&A REVIEW ON HVACR

## **M&A ENVIRONMENT**

While the market remains muted, we anticipate that transaction activity will recover in Q4 2024 with further acceleration anticipated in 2025 when the US election is in the rear-view mirror. Origin recently attended ACG Chicago's Midwest Capital Connection. The sentiment was consistent – investors and buyers alike are gearing up for an active M&A market in 2025.

Savvy buyers and investors are focusing on crucial operational traits—such as the strength and depth of the team, the array of products and services, the composition of customers and suppliers, distribution capabilities, reputation, and brand recognition—when assessing potential acquisitions. Businesses with strong, growing operations meeting these buyer and investor criteria are appealing and strategically positioned, offering no shortage of options for transitioning their companies, whether through a direct sale to a strategic buyer or a newly formed partnership with a financial investor. With that said, the "bar" for diligence is as high as we can remember. The process to close is extensive and burdensome.

We are encouraging clients to get started, if the plan is to transact in 2025. If we do see an uptick in activity in Q4 2024 and 2025, it is incumbent on sellers to not wait and move when there is less competition for attention in the M&A market for deals. Planning is key.



## PERFORMANCE OF PUBLICLY LISTED HVACR COMPANIES

Our conviction remains unchanged: public companies will continue seeking acquisitions of differentiated product and service companies within the HVACR space to bolster organic growth. Across the industry, the Q3 2024 Enterprise Value/EBITDA median multiple increased to 15.8x from 12.1x in Q3 2023.
